#### 1. State of Township:

Cemetery deal is still inching its way along. Fire millage renewal passed last summer. Meeting room/bathrooms painted and new carpeting last year. Purchasing 3 new election machines this year. One election scheduled this year, in November (Altran and school millage requests). Recreation Plan expires the end of 2017 and need updating. Finally, cell service (AT&T) in Shingleton. The Fire Department started looking at specs for next truck. "Clean-Up Day" scheduled for May 20<sup>th</sup>. Some thoughts... Should we recycle our waste paper? Should we consider solar panels for this building? Should we put some of our money into a CD?

#### 2. Discuss and Adopt Salary Resolution:
